* Summary of 2019-2020 AGM held 21st March 2021.

This MSYRG AGM was late due to COVID19 lockdown in November and we finally held it via ZOOM. Thankyou members who participated. A new committee member James Syme was welcomed and we thanked Graham Hogarth and Henry Birner who retired from the Committee. All other Office Bearers were elected and the 2019 AGM Minutes and the 2019-2020 Financials were passed with a zoom quorum. Michael Butcher gave his President's Report and reviewed MSYRG activities and achievements over the last 18 months. Major achievements around SY heritage issues included involvement with the State Heritage Planning Policy Amendment and a MSYRG submission to the CoM Heritage Review. MSYRG involvement has mitigated MMRA's activities in South Yarra with few trucks on our streets. During the CoM Council elections members received Bulletins with CoM candidate information and details about the Local Government Act and the issue of donations. Local issues included the PopUpPark initiative by MMRA/CoM, parking compliance along Domain Road, Building Planning Permit challenges (Goodrest, Entrecote & St Arnaud) and CoM Fawkner Park Pasley Street North Improvements which MSYRG supported. Increasing membership and committee numbers are a focus. MSYRG is also keen to hear from members about concerns and possible initiatives MSYRG could become involved in.

Michael Butcher highlighted current membership concerns-

* PARKING PERMITS FOR THOSE WITH IMPAIRED MOBILITY

A <u>NEW</u> Accessible Parking Permit Scheme was launched on March 22 by VicRoads across Victoria. These are Permits that give parking concessions to those with impaired mobility and it replaces the current system. * COMMUNITY VISION WORKSHOP 27/3/21 - REPORT

Two MSYRG committee members recently attended a CoM workshop aimed at refreshing the CoM 10 year Community Vison which is the backbone to future planning. There were also several others South Yarra residents attending as well as several councillors and council officers. At the Workshop we all gave feedback on 7 key aspirations. State Legislation now requires councils to have and implement a "community engagement "policy and as part of this the CoM has created an office with this responsibility which will give MSYRG a strong point of contact where we can be listened to and achieve action. The final report will be published in June 2021. The MSYRG committee will now aim to meet the new councillors and write to CoM to express our strong wish to be involved in the development of the Domain Village when the metro project is complete.
